Il sito comprende un piccola area dell'alta pianura friulana costituita da sedimenti grossolani carbonatici. Il paesaggio vegetale è omogeneo ed è dominato da formazioni erbacee xeriche di tipo substeppeico, a diverso grado di evoluzione. Si tratta di un'isola con ambienti naturali nell'ambito di un paesaggio rurale di tipo intensivo.

4.2 Quality and importance

Il sito comprende una delle poche superfici rimaste occupate da xerogramineti di tipo illirico substeppeico, molto importanti da un punto di vista floristico e fitogeografico. Il sito ha una rilevanza ornitologica limitata, con presenza discreta di specie legate ad ambienti steppici come Coturnix coturnix e Miliaria calandra.
